Altman has performed at the White House twice and has shared concert stages with Billy Joel, Steve Miller, Whoopi Goldberg, and Jay Leno.

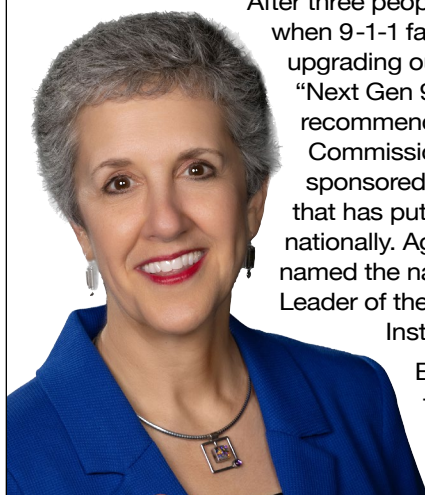

## About State Senator Cheryl Kagan

Vice Chair of the Education, Energy, & Environment (and Elections!) Committee, Senator Cheryl Kagan proudly represents Gaithersburg and Rockville.



After three people died in her district when 9-1-1 failed, Kagan focused on upgrading our emergency systems to “Next Gen 9-1-1.” Working from the recommendations of the statewide Commission she chaired, she sponsored and enacted legislation that has put Maryland at the forefront nationally. Again this year, she was named the national 9-1-1 Government Leader of the Year by the NG911 Institute.

Election law has been in the news and quite divisive. Kagan has helped ensure that voting remains

accessible, transparent, and accurate. Known as the “Senator for the nonprofit sector,” Sen. Kagan has launched a National Nonprofit Caucus to swap ideas with bipartisan legislators from around the country. Among her other legislative priorities are transparency and accountability in government; consumer protection; environmental initiatives; and health care.

Senator Kagan serves on the federal Election Assistance Commission; as Vice Chair of the National Conference of State Legislatures’ Elections & Redistricting Committee; the National Interoperability Commission; the Maryland State Arts Council; and more. She has been recognized by groups including the League of Conservation Voters, the Maryland Association of Counties, and the Maryland Municipal League.

Since 2003, Kagan has hosted “Folk ‘N Great Music,” which presents national singer/songwriters in Rockville. She is a nationally ranked Scrabble competitor and is proud to have brought and helped host the National Championships to Baltimore in 2022... and hopefully again in the coming years!
